Agreement terms

Due to the current pandemic and the need to social distance and ensure everyone's safety cat(s) are to be dropped off, at the door in their carrier and cat owners will not be allowed to take their cat into the kennel.

Drop off and pick up will be by appointment only. When it is time for the cat(s) to be picked up they will be waiting at the door for the owner. Please schedule a drop off and pick up time to ensure I am available to receive the cat(s) and to have the cat(s) in the carrier for pick up.

Purrfect Inn agrees to exercise due and reasonable care in the boarding of your pet, maintain the premises in a clean and sanitary condition and agrees to provide pet care services in a reliable and trustworthy manner.

Purrfect Inn agrees to administer routine medications, but we are unable to care for acutely sick or aggressive/ biting cats.

Owner agrees to pay the rate for boarding and any other charges related to food replenishment, flea treatment or veterinary services deemed necessary for the well-being and safety during your cat's stay. Payment for the reservation is required at or prior to drop off.

Owner certifies to the best of their knowledge their cat is healthy at the time of drop off and hasn't suffered a contagious illness in the previous 2 weeks.

Owner acknowledges that even with vaccinated pets, it is possible for them to become ill. You understand this risk and agree to pay any veterinary fees incurred, should your pet become ill.

Owner agrees to provide information about any special dietary requirements, medications, or behavioral issues.
